ADVANCED CARPENTRY SAFETY SKILLS CLUSTER

Units from CPC30220 Certificate III in Carpentry

The program is a half-year program designed for students wishing to explore a career in the building and construction industry. Advanced Skills Programs provides stackable VET options for students within a FIP, who have completed a relevant Certificate I or II qualification and have not secured a school-based apprenticeship. The focus is on providing hands-on practical experience in the trade area of carpentry and providing candidates with safety units preferred by employers.

\$2350 for non-eligible CITB funding

CITB Funding Criteria:

- Certificate I in Construction (D2C) or
- Certificate II in Construction (D2C) **OR**
- Certificate II in Construction Pathways (D2C)

And undertaken 10-day industry-based work placement.



Dates and Times:

18 weekly sessions at ATEC. One day a week during school days from 08:45 until 15:15.

School holidays are used for the structured workplace learning requirements.

Commencement date: Week two, Term one.



Entry Requirements:

- Have a genuine interest in a construction-related pathway
- Have the physical ability to undertake practical tasks required for construction work.
- Have the ability to read, write and understand basic English and carry out basic mathematical calculations
- Hold a valid White Card
- Have completed a relevant Certificate I or II qualification
- Completed 10-day industry-based work placement
- Be able to commit to the course duration and time commitment.
- Students will be required to complete a Language, Literacy, Numeracy (LLN) suitability review prior to enrolling the training course

Orientation Details:

Orientation is undertaken on the first training day. Students to meet at ATEC reception.



Work Placement:

5 days

Students and their families are responsible for organising 5 days of Structured Workplace Learning (SWL) in the construction industry. The 5 days of SWL must be completed by the end of the Term 3 holidays.



PPE Requirements:

Eligible Participants will be provided with a top up PPE pack (earmuffs, safety specs, gloves, glove clip and hi viz shirt)



Pathways:

This course leads to a Certificate III in Carpentry, including School-Based Apprenticeships and full-time Apprenticeships.



Students:

Minimum of 12 students and a maximum of 15 per class.
