Our 2-Day forklift course provides the skills and knowledge required to operate a forklift truck safely in accordance with all relevant legislative requirements. This course is required to be completed and passed so that you may apply for and be issued with a High Risk Work Licence for forklift (LF class) issued by SafeWork SA Note: Our 2-day Forklift Training Course is designed for people with minimal or no forklift experience.

Duration & Assessment

The 2-Day training course that we offer at ATEC involves a 3-stage learning process, as follows:

• Stage 1: Pre-course theory – consisting of our learner resource and an 84-question (true/false & multi choice) assessment.

This will need to be completed to attend stage 2 of training

- Stage 2: Day 1 of the face-to-face theory & practical block at either our Lonsdale or Ottoway site (calculations, forklift checks/maintenance and practical.)
- Stage 3: Safe Work SA Day Theory & Calculations Assessment - Closed Book & Practical Assessment

Entry Requirements

Participants MUST:

- Be at least 18 years of age
- Be an Australian/New Zealand Citizen or hold an eligible VISA.
- Have the ability to read, write and understand basic English and carry out basic mathematical calculations independently.
