Overview

Our 2-Day forklift course provides the skills and knowledge required to operate a forklift truck safely in accordance with all relevant legislative requirements. This course is required to be completed and passed so that you may apply for and be issued with a High Risk Work Licence for Forklift (LF class).

Note: Our 2-day Forklift Training Course is designed for experienced forklift operators.

Duration & Assessment

The 2-Day training course that we offer at ATEC involves a <u>3-Stage</u> learning process, as follows:

• Stage 1: Pre-course online theory – consisting of our learner resource and an 84-question (true/false & multi choice) assessment.

This will need to be completed to attend stage 2 of training

- Stage 2: Day 1 of the face-to-face theory & practical block at either our Lonsdale or Ottoway site (Covering calculations, forklift checks/maintenance and practical)
- Stage 3: Day 2 SafeWork SA Theory & Calculations Assessment – Closed Book & Practical Assessment by an approved SafeWork SA Assessor.

Entry Requirements

Participants MUST:

- Be at least 18 years of age
- Be an Australian/New Zealand Citizen or hold an eligible VISA.
- Have the ability to read, write and understand basic English and carry out basic mathematical calculations independently.

Please keep in mind, If you have English language, literacy and or numeracy issues and fail to disclose them, you may not satisfactorily complete the training, resulting in loss of fees paid. ATEC cannot be held responsible for a person's inability to successfully complete a course.
