

# (LF)Forklift Training & Assessment (2 Days) TLILIC0003 - Licence to operate a forklift truck



## **Overview**

Our 2-Day forklift course provides the skills and knowledge required to operate a forklift truck safely in accordance with all relevant legislative requirements. This course is required to be completed and passed so that you may apply for and be issued with a High Risk Work Licence for forklift (LF class) issued by SafeWork SA **Note:** Our 2-day Forklift Training Course is designed for people with minimal or no forklift experience.

## **Duration & Assessment**

The 2-Day training course that we offer at ATEC involves a <u>3-stage</u> learning process, as follows:

• **Stage 1:** Pre-course theory – consisting of our learner resource and an 84-question (true/false & multi choice) assessment.

This will need to be completed to attend stage 2 of training

- Stage 2: Day 1 of the face-to-face theory & practical block at either our Lonsdale or Ottoway site (calculations, forklift checks/maintenance and practical.)
- Stage 3: Safe Work SA Day Theory & Calculations Assessment – Closed Book & Practical Assessment

## **Entry Requirements**

Participants MUST:

- Be at least 18 years of age
- Be an Australian/New Zealand Citizen or hold an eligible VISA.
- Have the ability to read, write and understand basic English and carry out basic mathematical calculations.

Please keep in mind, If you have English language, literacy and or numeracy issues and fail to disclose them, you may not satisfactorily complete the training, resulting in loss of fees paid. ATEC cannot be held responsible for a person's inability to successfully complete a course. Particularly in circumstances where the student fails to disclose pertinent information in their application for enrolment.

## **Course Fees**

- \$470.00 (GST exempt)
- \$270.00 (GST exempt) with a valid CITB

Courses must be paid for on booking unless alternative arrangements have been made. Training will not be confirmed until payment has been received.

## **Re-Sit**

In the event you do not pass the <u>Safe Work SA</u> <u>assessment</u>, you will have the opportunity to re-book and re-sit this day of training. You will need to have successfully gained the TLILIC0003 unit.

\*\*You will need to take your Tax Invoice to a Service SA Customer Service Centre in SA within 60 Days of issue. Your HRWL Card will be mailed to you.
